THE LACK OF VARIETY AND NUTRITIONAL VALUE LED TO WIDESPREAD MALNUTRITION AND WEAKENED IMMUNE SYSTEMS. DISCIPLINE WAS RIGID, ENFORCED THROUGH DRILLS, INSPECTIONS, AND A STRICT HIERARCHICAL STRUCTURE. SOLDIERS WERE EXPECTED TO MAINTAIN THEIR EQUIPMENT, OBEY ORDERS WITHOUT QUESTION, AND PARTICIPATE IN DAILY ROUTINES THAT RANGED FROM GUARD DUTY AND FATIGUE DUTIES TO TRAINING EXERCISES, ALL AIMED AT MAINTAINING ORDER AND READINESS AMIDST THE CHAOS OF WAR. THE REGIMENTED NATURE OF CAMP LIFE, WHILE SOMETIMES STIFLING, WAS ESSENTIAL FOR MAINTAINING A COHESIVE FIGHTING FORCE.

### THE EVER-PRESENT THREAT OF DISEASE

DISEASE PROVED TO BE A MORE INSIDIOUS AND DEADLY ENEMY THAN THE BRITISH REDCOATS FOR MANY REVOLUTIONARY SOLDIERS. THE LACK OF UNDERSTANDING OF GERM THEORY MEANT THAT PREVENTATIVE MEASURES WERE RUDIMENTARY AT BEST. SOLDIERS OFTEN LACKED ADEQUATE MEDICAL SUPPLIES AND TRAINED PERSONNEL, LEAVING THEM VULNERABLE TO INFECTIONS AND CHRONIC CONDITIONS. THE CONSTANT THREAT OF SICKNESS ADDED ANOTHER LAYER OF HARDSHIP TO AN ALREADY CHALLENGING EXISTENCE, UNDERSCORING THE IMMENSE PHYSICAL TOLL OF MILITARY SERVICE DURING THIS ERA.
