As in *Mimesis*, Auerbach's fresh insights bring to the disparate subjects of the essays a coherence that reflects the unity of Western, humanistic tradition, even while they hint at the deepening pessimism of his later years. In the first essay, *Figura*, Auerbach develops his concept of the figural interpretation of reality; applied here to Dante's *Divine Comedy*, it

also served as groundwork for his treatment of realism in *Mimesis*. A second essay on Dante's examines the poet's depiction of St. Francis of Assisi. The next three essays deal with the paradoxical nature of Pascal's political thought; the merging of *la cour* and *la ville*—the king's entourage and the bourgeoisie—chiefly in relation to the seventeenth-century French theater; and Vico's formulation concepts by the German Romantics. In the final essay Auerbach confers upon Baudelaire's *Fleurs du Mal* the designation aesthetic dignity because, not in spite of, the hideous reality of the poems.
