IT'S ABOUT DECIPHERING THE AUTHOR'S MESSAGE, THE CONTEXT IN WHICH IT WAS CREATED, AND ITS POTENTIAL IMPACT ON THE AUDIENCE. THE ROLE OF CONTEXT IN INTERPRETATION

WITHOUT ADEQUATE CONTEXTUAL KNOWLEDGE, AN INTERPRETATION CAN BE SUPERFICIAL OR ENTIRELY MISGUIDED. THIS IS A FOUNDATIONAL ELEMENT FOR ANY LESSON 8 INTERPRETATION EXERCISE.

IDENTIFYING AUTHORIAL INTENT AND BIAS

INTERPRETING VISUAL AND DATA-DRIVEN CONTENT

BEYOND TEXTUAL ANALYSIS, INTERPRETATION EXERCISES FREQUENTLY EXTEND TO VISUAL MATERIALS AND NUMERICAL DATA. THESE FORMS OF CONTENT REQUIRE A DIFFERENT SET OF ANALYTICAL SKILLS BUT SHARE THE CORE OBJECTIVE OF DERIVING MEANING AND UNDERSTANDING FROM WHAT IS PRESENTED. MASTERING THESE DIVERSE INTERPRETATION FORMS IS VITAL FOR A WELL-ROUNDED LESSON 8 INTERPRETATION EXERCISE.

DECONSTRUCTING VISUAL ELEMENTS

OVER-INTERPRETATION CAN LEAD TO UNSUPPORTED CONCLUSIONS, WHILE UNDER-INTERPRETATION RESULTS IN A SUPERFICIAL ANALYSIS. STRIVING FOR A BALANCED APPROACH, SUPPORTED BY SOLID EVIDENCE, IS KEY TO AVOIDING THESE PITFALLS IN YOUR LESSON 8 INTERPRETATION EXERCISE.

DEALING WITH AMBIGUITY
