ELIGIBILITY REQUIREMENTS FOR LACHIP AFFORDABLE INTERNET

TO QUALIFY FOR THE LACHIP AFFORDABLE PLAN, APPLICANTS MUST MEET SPECIFIC INCOME-BASED OR PROGRAM-PARTICIPATION CRITERIA. THESE REQUIREMENTS ARE IN PLACE TO ENSURE THAT THE PROGRAM ASSISTS THOSE WHO NEED IT MOST. UNDERSTANDING THESE CRITERIA IS THE FIRST STEP IN DETERMINING YOUR ELIGIBILITY.

LOW-INCOME GUIDELINES

HOW TO APPLY FOR THE LACHIP AFFORDABLE PLAN

- **PROOF OF IDENTITY:** A VALID GOVERNMENT-ISSUED ID, SUCH AS A DRIVER'S LICENSE OR PASSPORT, MAY ALSO BE REQUIRED.

FINDING PARTICIPATING INTERNET SERVICE PROVIDERS

THE FIRST STEP IN SECURING AN AFFORDABLE LACHIP PLAN IS TO IDENTIFY WHICH INTERNET SERVICE PROVIDERS IN YOUR AREA PARTICIPATE IN SUCH PROGRAMS. MANY NATIONAL AND REGIONAL PROVIDERS OFFER PLANS THAT ARE COMPLIANT WITH THE AFFORDABILITY REQUIREMENTS.

IT'S ADVISABLE TO CHECK THE OFFICIAL GOVERNMENT WEBSITES OR CONTACT THE PROGRAM ADMINISTRATORS DIRECTLY TO GET AN UP-TO-DATE LIST OF PARTICIPATING PROVIDERS. THESE LISTS ARE OFTEN CATEGORIZED BY STATE OR REGION, MAKING IT EASIER TO FIND LOCAL OPTIONS. ONCE YOU HAVE A LIST, YOU CAN VISIT THE WEBSITES OF INDIVIDUAL PROVIDERS TO SEE THEIR SPECIFIC OFFERINGS UNDER THE AFFORDABLE INTERNET INITIATIVES.

FEATURES OF AFFORDABLE LACHIP INTERNET PLANS

- INSTALLATION FEES MAY BE WAIVED OR SIGNIFICANTLY REDUCED.

HOWEVER, IF YOU HAVE MULTIPLE USERS OR ENGAGE IN DATA-INTENSIVE ACTIVITIES LIKE ONLINE GAMING OR FREQUENT VIDEO CONFERENCING, YOU MIGHT NEED TO LOOK FOR PLANS WITH HIGHER SPEEDS, WHICH MAY STILL BE AFFORDABLE THROUGH THE SUBSIDY. DATA CAPS, IF PRESENT, LIMIT THE AMOUNT OF DATA YOU CAN USE PER MONTH. MANY AFFORDABLE PLANS OFFER UNLIMITED DATA, BUT IT'S ALWAYS WISE TO CONFIRM THIS DETAIL.
