Bu ekonominin bir kesimini oluşturan kara ekonomi, başta uyuşturucu trafiği, silah kaçakçılığı, insan ticareti ve yolsuzluklar olmak üzere muazzam tutarlarda kara para ya da kirli para doğuran bir çok suç faaliyetini içerir. Bu faaliyetler, genelde örgütlü ve gelirleri de nakit formundadır. Bunu izleyen aşamada ise, 1980'lerden itibaren uluslararası toplum ile finans ve hukuk dünyasının gündemine oturan ve yasadışı yollardan elde edilen gelirlerin statüsünün değiştirilerek, normal ve temiz bir kazanç gibi yasal ekonomiye sokulmasına imkân veren metotların tümü olarak tanımlanabilecek aklama işlemi devreye girmektedir. Aklanan suç gelirleri, yine kazanç sağlayıcı suç faaliyetlerinde kullanılarak, birbirini besleyen ve giderek büyüyen bir suç-kazanç zinciri sarmalı halinde, sosyal,ekonomik ve demokratik yapıları da tahrip eden suç ekonomisine diğer bir anlatımla kara ekonomiye altyapı oluşturmaktadır. Kara ekonomi ise yasal ekonomik faaliyetler içinde sağlıklı bir vücudu giderek kangrenlestiren bir kanser gibi yayılmaktadır. Bu yönüyle karapara aklama çağdas

ekonominin bulasıcı hastalığı olarak da görülebilir. Aslında, suc kazancını aklama ihtiyacı, suc ve suçlulukla özdeş bir tarihi geçmişe sahiptir. Suçluların ellerindeki paraların suçtan kazanıldığı biliniyorsa, söz konusu kirli kazançlar sadece bir para koleksiyonundan ibaret olur. Dolayısıyla, kara para herşeyden önce kullanılabilmek için aklanmak zorundadır. Dünya kara sandığının tutarı 1 ilâ 2 trilyon dolar arasında tahmin edilmektedir. Asgarî rakam gözönüne alınsa bile, bu Fransa bütçesinin 3 katına denk gelmektedir. Bunun yarısı ise, uyuşturucu kaçakçılığından gelmektedir. Hukuk bu muazzam tutarların aklanmasına kayıtsız ve eli kolu bağlı kalamaz. Çünkü ilk olarak, aklanan bu fonların bir bölümü tekrar uyuşturucu kaçakçılığı, terör ve diğer örgütlü suçların finansmanında kullanılmaktadır. Bu para vasıtasıyla ve özellikle rüşvet, şantaj, haksız rekabet gibi mafyöz metotlarla kamusal hayatın ve malî dolaşımların denetimi yoluyla suç örgütleri giderek güçlenmektedir. Suç gelirleri aklanarak buharlaştığı zaman en önemli suç kanıtları da kaybolmakta, suçluların ceza görme riski azalmakta, bu ise ceza sisteminin etkinliğine zarar vermektedir. Suçlular sahip oldukları bu muazzam kara fonlar sayesinde politik ve ekonomik sisteme etki etmekte, hukuk devletini ve bu devletin egemenliğini zayıflatmaktadır. Nitekim bugün dünyada, uyuşturucu kara parası sahiplerinin kontrolüne girmiş ekonomilerden (narko ekonomiler) ve uyuşturucu kartellerinin gölge iktidar oldukları "narkodevletler" den bahsedilmektedir. Kolombiya, Bolivya, Peru, Meksika ve Tayland gibi söz konusu ülkeler, siyasî ve ekonomik istikrarsızlık ve krizlerle boğuşmaktadırlar. 90'lı yıllardan itibaren gündeme oturan malî küreselleşme ile birlikte, aklama faaliyetleri artmış, sınıraşan nitelik kazanmış, ayrıca kullanılan teknikler de çeşitlenmiş ve karmaşıklaşmıştır. Hatta para aklama sınıraşan örgütlü suç faaliyetlerinin doğal bir boyutu haline gelmiştir. Bu gelişmeyi vurgulamak için artık "mafyalar daha beyaz yıkar " ifadesi kullanılır olmuştur. Günümüzde sınır tanımayan bir olgu halini alan kara para aklamayla mücadelede, mülkilik ve ulusal egemenlik prensiplerine bağlı mevcut ceza hukukunun yetersiz kaldığı uzmanlar arasında kabul görmektedir. Diğer yandan, kestirilemeyen kararlar ve sermaye hareketleri aracılığıyla ekonomik mekanizmaları ve dengeleri istikrarsızlaştırma riski taşıması dolayısıyla, kara para aklama ekonomi için de ölümcül bir risktir. Çünkü aklayıcıların mantığı klasik kâr ve en iyi yatırım mantığı değildir. Aksine, yatırım kolaylıklarını, özellikle bankacılık, şirketler hukuku ve ceza hukuku alanlarında mevzuatın gevşekliğine bakmaktadırlar. 11 Eylül saldırılarının ardından kara para aklama ve terörün finansmanıyla mücadele birlikte anılır olmuştur. Zira bu olay, bir terör örgütünün dünyayı nasıl sarsabileceğini göstermiştir. İstanbul, Madrid ve Londra saldırıları da tüm insanlığı hedef alan hiperterör tehdidini tevit etmistir. Sorunun odağında finans boyutu öne cıkmaktadır. Cünkü, terör örgütleri de tıpkı mafyalar gibi, faaliyetlerini finanse edecek fonları sağlayacak suç gelirlerini özellikle uluslararası malî dolaşımlar içinde aklamaktadırlar. Gelir kaynakları kurutulmuş bir terör örgütü çok çok az tehlike oluşturur. Bu noktada kara para aklamanın önlenmesi ve cezalandırılması, terörün finansmanının engellenmesine de yaramaktadır. Ancak terör örgütlerinin bir kısım gelirleri yasal ticarî faaliyetlerin gelirleri ile yardım kampanyalarında sağlanan paralara ya da bireysel bağışlara, hatta bazı devletlerin doğrudan parasal yardımına dayanmaktadır. Kaynağı meşru, dolayısıyla kara para olarak nitelendirilemeyecek söz konusu gelirler, gizli dolaşımlara sokularak silah satın almaları ya da eylemcilerin maaşını verme gibi amaçlarla, örgüt hücrelerine tahsis edilmektedir. Görüldüğü gibi, burada aklamanın tam tersi bir işlem söz konusu olup, yabancı literatürde "tersine aklama" ya da "temiz parayı kirletme" işleminden bahsedilmektedir. 29-30 Ekim 2001'de Waşington'da toplanan FATF, kara para aklama ile mücadele görevini terörizmin finansmanına da genişletmiş ve bu alanda 8 özel tavsiye kararı almış, yine haziran 2003'de, 40 tavsiye kararını bu yeni tehdidi de içerecek şekilde yenilemiştir. Diğer yandan, büyük miktarlı aklama olayları, hemen hemen her zaman uluslararası bir nitelik taşır. Uluslararası kara para aklama işlemleri, genelde çok karmaşıktır ve ortaya çıkarılmaları hukukî, cezaî, malî, polisiye ve idarî tüm boyutlarını göz önüne alan çok yönlü bir yaklaşım ve çabayı gerektirir. Sınıraşan suçlar ve bu bağlamda uluslararası Suç A.Ş'ler olarak nitelendirilen küresel mafyalarla mücadele de, bir süredir uluslararası yasama politikasının odağında yeralmaktadır. Bu bağlamda gelirlere doğru yönlendirilen suçluluğu kontrol stratejileri, tamamen yeni bir önem kazanmıştır. Bu bakış açısından, bir yandan karapara aklamayla cezai mücadele, öbür taraftan da karaparanın müsaderesi, suçlulukla mücadele

stratejisinin sonuc alıcı öğeleri olarak kabul görmektedir. Her iki unsur birarada cifte strateji oluşturmaktadır. Bir yanda karapara aklama suçu failini (in personam) hedefleyen cezai yaptırım, diğer tarafta suçun maddi konusunu (in rem) hedefleyen şüphelinin mallarına müsadere amaçlı el koyma. Gerçekten, son on beş yıl içinde uluslararası finans sektöründe karapara ile mücadele kapsamında meydana gelen önemli gelişmel İngilizce literatürde eri "Üç F" ile özetlenmektedir: Finding-Bulma, Freezing-Dondurma, Forfeiture-El koyma Diğer yandan, son zamanlarda hız kazanan aklamaya karşı uluslararası girişimler ile ulusal mevzuatlar hükümlerinin uygulamada amaçlanan sonucu vermesi için, bu konudaki ulusal aktörlerin (Adli makamlar, kolluk, Mali İstihbarat Birimi, denetleyici kurumlar) imkanlarının arttırılması ile kendi aralarında ve uluslararasındaki muhataplarıyla daha sıkı bir işbirliğine yönelik mekanizmaların da hayata geçirilmesi şarttır. He also adds practical examples and questions to each chapter to better facilitate the involvement of students and readers, plus a section on motivational interviewing.
