An organic waste management strategy that was developed in the Albania context is also presented and discussed. Anaerobic digestion is one of the most widely studied technologies in this field, and this process is responsible for the production of biogas or methane, even in fossil resource-rich countries. On the other hand, aerobic fermentation is considered for the degradation of very toxic organic substances that can be dissolved into aqueous solutions that aid in the recovery of valuable materials from electrical and electronic equipment that do not have further use. There are a wide range of arguments and experiences that support the use of waste as a resource through disposal with simultaneous energy enhancement and the production of new materials, thus limiting the use of non-renewable resources for more sustainable development for the benefit of future generations.
