An isolation which is deeply rooted within a person who does not fit into the narrow-minded and prefabricated picture of the stereotypical southern society. Finally, my paper emphasizes Carson McCullers' concern with gender and behavioral concepts in the early 20th century, which she turned upside down in order to uncover the artificiality of the southern myth and its rigid moral conceptions.
