IMPIETY

IMPIETY, OR ASEBEIA, WAS A SERIOUS OFFENSE IN ATHENS, ENCOMPASSING DISRESPECT TOWARD THE GODS OR RELIGIOUS PRACTICES. SOCRATES WAS ACCUSED OF BELIEVING IN SUPERNATURAL ENTITIES NOT SANCTIONED BY THE ATHENIAN RELIGION, WHICH WAS INTERPRETED AS A FORM OF RELIGIOUS SUBVERSION.

CORRUPTING THE YOUTH

THE VERDICT AND SENTENCING
