National Transportation Safety Board, 2006 Three persons, including the conductor of the UP train and two local residents, died as a result of chlorine gas inhalation. The UP train engineer, 23 civilians, and 6 emergency responders were treated for respiratory distress or other injuries related to the collision and derailment. Damages to rolling stock, track, and signal equipment were estimated at 5.7 million, with environmental cleanup costs estimated at 150,000. The safety issues discussed in this report are train crew fatigue and the vulnerability, under current operating practices, of railroad tank cars carrying hazardous materials.
