The Army had sent large expeditionary forces beyond the American hemisphere, and at the beginning of the new century Secretary of War Elihu Root had proposed changes and reforms that within a generation would shape the Army of the future. But world war-global war-was still to come. The second volume of this new edition will take up that story and extend it into the twenty-first century and the early years of the war on terrorism and includes an analysis of the wars in Afghanistan and Iraq up to January 2009.

The Army-Navy rivalry is also about traditions, and in a concluding chapter on the 2004 game, the authors take us through the pageantry: the march into the stadium by the student bodies of both

schools; freshman push-ups after each score; and the final, moving show of sportsmanship following the game as thousands of cadets and midshipmen stand at attention while the alma mater of each school is played by their respective bands. A rivalry like no other, Army versus Navy receives due recognition in this colorful, thorough history.
