And one unethical doctor was exploiting other people's tragedies. Jane Blasio was one of those babies. At six, she learned she was adopted. At fourteen, she first saw her birth certificate, which led her to begin piecing together details of her past. Jane undertook a decades-long personal investigation to not only discover her own origins but identify and reunite other victims of the Hicks Clinic human trafficking scheme. Along the way she became an expert in illicit adoptions, serving as an investigator and telling her story on every major news network.
