BODY PARAGRAPHS

THE CORE OF THE LETTER SHOULD DETAIL THE APPLICANT'S SKILLS, EXPERIENCES, AND ACCOMPLISHMENTS THAT DIRECTLY RELATE TO THE DESIRED ROLE OR PROGRAM. SIGNATURE

END WITH A PROFESSIONAL CLOSING PHRASE SUCH AS "SINCERELY" OR "BEST REGARDS," FOLLOWED BY THE APPLICANT'S TYPED NAME. IF SUBMITTING A HARD COPY, A HANDWRITTEN SIGNATURE MAY BE ADDED ABOVE THE TYPED NAME.

HOW TO FORMAT YOUR COLUMBIA COVER LETTER
