The Chiropractor would locate the incipient occluded foramen at that point on left side. Pressure on nerves was the cause of excessive heat, more especially on the affected side softening (11th and 7th dorsal and contiguous

vertebrae..Muscular compression, while vertebrae were soft, made centra wedge-shaped. This abnormal condition was undoubtedly done in youth. The ribs on right side grew to normal size; they show deformity only in distal half; which is thinner and more flat. The left ribs are micromegalous. Those adjacent to the occluded foramina are more so than others. Observe the difference in the cartilage of different ribs. ILLUSTRATION NO. 81. SMALL POX. Small pox and chicken pox are one and the same disease. A bad case of chicken pox; a mild case of small pox is chicken pox. They differ in degree and symptoms as do all diseases in different individuals. All ailments are but the effects of abnormal nerve impulse.
