In that difference rests the dynamism of their "upstream-downstream" relationship, which, thereafter, became a regular historical pattern in Myanmar history, represented today by inland Naypyidaw and "coastal" Yangon. Original in conception and impressive in scope, this well written book not only fills in the history of early modern Myanmar but places it in a broad interpretive context based on years of familiarity with a wealth of primary sources. Full of arresting anecdotes and colorful personalities, it represents an important contribution to Myanmar studies that will not easily be superseded.
