OVERVIEW OF DA FORM 5960 ARMY

THE FORM IS PRIMARILY UTILIZED DURING MEDICAL HOLD STATUSES OR WHEN A SOLDIER IS PENDING MEDICAL EVALUATION FOR DISABILITY OR RETIREMENT. IT SERVES AS AN OFFICIAL RECORD THAT ENSURES THE SOLDIER'S PAY AND ALLOWANCES ARE MAINTAINED WHILE UNDERGOING TREATMENT OR EVALUATION.

FORM DESCRIPTION AND IDENTIFICATION

ENSURING PAY CONTINUITY

SUBMISSION AND PROCESSING PROCEDURES

Some documents found on the web are missing some pages or the image quality is so poor, they are difficult to read.
