Typically large and sprawling, boomburbs are accidental cities, but not because they lack planning. Many are made up of master-planned communities that have grown into one another. Although boomburbs possess elements found in cities such as housing, retailing, offices, and entertainment, they lack large downtowns. Urban in fact but not in feel, these drive-by cities of highways, office parks, and shopping malls are much more horizontally built and less pedestrian friendly than most older suburbs.
