States that integrate the HMGP with their frequently updated State Administrative and Hazard Mitigation Plans will create cohesive and effective approaches to loss reduction. This type of coordinated approach minimizes the distinction between "predisaster" and "post-disaster" time periods, and instead produces an ongoing mitigation effort. Hazard mitigation is any sustained action taken to reduce or eliminate long-term risk to people and property from natural hazards and their effects. The course contains disaster-related examples, activities and case studies that relate to EOC's and multi-agency coordination systems at the local, state and federal levels of government.Course Objectives:At the end of the course, students should be able to: *Relate EOC operations to National Incident Management System (NIMS) requirements.*Describe the role that EOCs play in overall multiagency coordination.*Describe the relationship between the EOC and the on-scene Incident Command System (ICS) structure.*Identify staffing, information, systems, and equipment needs at the EOC.*Determine whether participants' EOC organizations are conducive to effective coordination.*Identify potential alternate locations suitable for EOC operations should the primary EOC facility become damaged or inoperable.*Create a test, training and exercise plan for critical EOC operations. *Develop a strategy and schedule for reviewing EOC resource requirements and technology needs.
